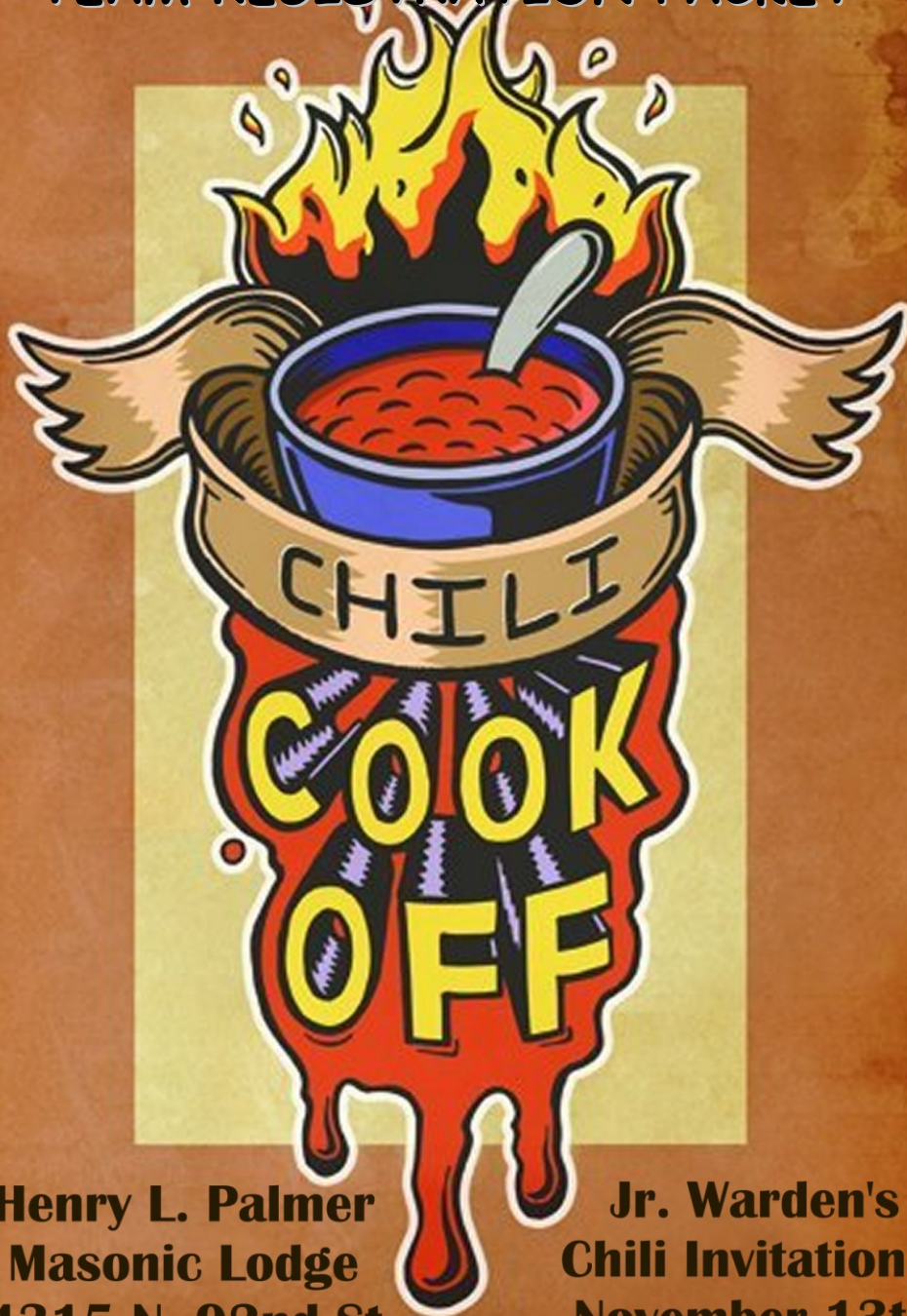

# The Rules

## General

1. Teams are encouraged to market their Lodge and / or services but no sales allowed at the event. Promotional items may be given away and decorations are encouraged.
2. Up to 2 persons per Chili Cook-off Team. These 2 people will receive an event ticket. All other personnel helping will need to purchase admission tickets. Tickets can be purchased at Henry L. Palmer Lodge, or from any Palmer Lodge officer.
3. Teams are responsible for supplying all chili ingredients and cooking containers. All teams must be self-supporting for event. Palmer Lodge will supply condiments, beverages, and other miscellany items.
4. All participants must sign the Waiver & Release that you will find on the registration form.

## Setup/Teardown

1. Each team will be allocated a table space of 8'x3'. Chili teams are responsible for their own cooking equipment, supplies and decorations.
2. Chili bowls, spoons, condiments, beverages and napkins will be provided.
3. Teardown will begin after the closing of the event on November 13th, 2011. Our kitchen must be completely free from garbage and other materials. Each team will be responsible for tear down of their designated area after the closing of the event.

## Chili

1. There are no restrictions on ingredients for your chili. Use of meats, beans, pasta, spices, and all other ingredients are up to the discretion of the cook teams. Teams can make more than one recipe for public sampling.
2. Label each type of chili using the criteria on the registration form you are preparing
3. Please have an ingredient list (not a recipe) ready for discerning patrons in case of food allergies or intolerances.
4. Tasting begins at 5 p.m.

## **Cooking**

1. All Chili Cook-off Teams will prepare their chili prior to the event.
2. A Gas Stove will be available for reheating. Serving containers will be provided by Henry L. Palmer Lodge.
3. All entrants are required to comply with all health department regulations

## **Judging / Awards**

1. There will be a centrally located ballot box for each person to place his or her vote in. All votes will be collected and individually counted at the registration table for final tally of votes. Chili Cook-off patrons will cast a vote to select the "People's Choice" award-winning chili. Ballots will be collected at 7:15 p.m. and the winner announced. Chili teams are encouraged to engage the cook-off patrons and encourage them to vote for their favorite chili. Your Team Name must be posted visibly on the front of your chili. An award will be given to the best in show.
2. The decisions of the "People Choice" are final. All entrants participate at their own risk. Henry L. Palmer Lodge #301 will not be liable for losses or damages resulting from team participation in this event. Event organizers reserve the right to change or modify these rules at any time. Any changes will be communicated to all entrants. Event Organizers reserve the right to disqualify any team for violation of these rules.
